## **OBJECTIVES OF CHILDREN BY CHOICE**

**The objects of the Association are:**

- i. To provide decision-making counselling to women and pregnant people who experience hardship and/or distress with a pregnancy.
- ii. To help alleviate the poverty and destitution of disadvantaged women, pregnant people and their families who seek to access abortion through the provision of material aid and practical assistance.
- iii. To support pregnant women and pregnant persons who are experiencing suffering and distress as a result of reproductive coercion, sexual assault and domestic violence.
- iv. To support women and people who can become pregnant, particularly those experiencing poverty, to access their preferred contraceptive and family planning options.
- v. To help women and people who can become pregnant out of the cycle of poverty and ill-health following the experience of unplanned pregnancy or abortion.
- vi. To support children experiencing pregnancy and violence, poverty and/ or disadvantage to achieve positive sexual and reproductive health outcomes, through the provision of counselling, information and material aid.
- vii. To disseminate information, provide education and promote public awareness of discrimination, stigma and inequity faced by women and people who can become pregnant in accessing their reproductive health choices.
- viii. To promote, by lawful means, legislation and policy that support safe, legal and compassionate access to abortion and reproductive healthcare.
- ix. To undertake and/or do other things or activities which are necessary, incidental or conducive to the advancement of these Objects.
